

MASS PATRIOTS VOLLEYBALL CLUB FINANCIAL AGREEMENT

SECTION 1 Conditions of participation

I, the parent/guardian of (player) have read the enclosed information concerning the policies and practices of the Mass Patriots Volleyball Club (hereafter called the "Club"). I agree, having been selected to a team, to let her join and participate in the club for the 2024-25 volleyball season.

I understand that I am responsible for all fees due by the player, as well as her transportation to weekly practices and all tournaments.

Travel within New England will be required for maintaining membership on the different teams. A player may be put on a different team depending on the development of the individual player including her commitment, coachability, behavior, etc..., and will be at the discretion of the Director of the Club and coaching staff.

I have read the material provided and understand the time commitment involved in practice and competition. I have reviewed the fee schedule in Section 2 of this agreement and understand that all fees must be paid in full regardless of the duration of participation by the individual. This is due to the fact that membership in the Club is limited and others were denied a position by your acceptance of a position on a team within the Club. **Total membership fee is due for each player even if a player is absent from a tournament date. Payments can be made by cash or checks made to "Mass Patriots" on site or credit card.**

Understanding the stipulations and having discussed these with my child, I agree to and will support her participation in the Club. I understand that once registered and having competed with the Club, the player will be unable to transfer clubs in any USAV Junior competition, the NERVA Championships and USAV Junior National Volleyball Championships. Post season play with another club is not allowed without permission from the Club Director and without completion of the current season tournament schedule of the specific Mass Patriots team.

The undersigned player and parent/guardian, hereafter designated as "member", agree to accept membership in the Mass Patriots Juniors Volleyball Club for the 2023-24 season. Membership entitles the member to participate in practices and tournaments designated by the Club. Equal opportunity to participate will be provided during practice, however, on court time at tournaments is not guaranteed, but is determined by the club coaching staff.

As the player/member, I understand the commitment I am making to the Club and I am willing to commit myself to the program and my teammates for the 2024-25 season.

SECTION 2 Membership Fees for Mass Patriots Teams

The cost of the club level teams will be \$850, due in 3 payments payable in November, January and February and travel teams will be \$1250 and is due in 4 payments payable in November, January, February and March. That information will be posted on the website and is in the chart below. **The first non-refundable membership fee of \$350 should be paid by players on all teams at the first practice date on 11/24/24.**

Players will be emailed within 24 hours of the second tryout, whether or not they have made the cuts for the program. Some teams may need the 3rd tryout to determine which team a player is appropriate for and players will be informed on that Sunday.

Personalized payment schedules may be arranged with the director of the Club or the Administrative Assistant. Members shall pay such sums as are herein agreed to be paid to the Club at its address. All checks are made payable to "Mass Patriots VBC". Payments can also be made in larger sums if you wish. If payments become delinquent and there is no payment schedule arranged or a payment schedule is neglected athletes will be told they cannot participate in tournaments and/or practice

The fees include base plan items; player uniform, warmups, NERVA Tournament entry fees, gym rental fees, equipment, coaches' stipend, coaches expenses, and a club administration fees.
